The fact that three minor rock edicts of Ashoka are found in this district, one at Maski in the Lingasur Taluka and the other two near Sindhanur prove that this area was included in the domination of great Mourya King Ashoka (273-236 B.C).

Sindhanur City is an important Commercial, Industrial and Educational centre in the Raichur district. Vijayanagar Kings and Sultans towns called as Sindhanur. In and around the Sindhanur town some of the following famous temples exist. Ambadevi temple at Somlapur village. Murari temple at Mukkunda village. Somanatha temple at pura village.-This belongs to Kustagi Taluka. One Masjid was constructed by the king Aurangzeb at a distance of 1.6 Km from this town. It occupies a central place in the Tungabhadra Ayacut area in the district and is an important centre of development activities under the Tungabhadra.

Being near to Tungabhadra Dam Sindhanur people will get sufficient water from it and most of people grown paddy and jawar.
